LETTER FROM THE EXECUTIVE DIRECTOR

Pura Vida, or Pure Life, is the Costa Rican National Motto and a state of mind to the "Ticos," the residents of Costa Rica. My new rally call—especially when it seems at times there are no real solutions to the many environmental issues we face.

While we were under the quiet blanket of winter back in February, I had the opportunity to take part in an EarthWatch volunteer research project at Las Cruces Biological Field Station, located near the city of San Vito in the Coto Brus region of Costa Rica. I saw first-hand how the impacts of habitat fragmentation and loss are being addressed in other places.

The purpose of this EarthWatch project is to understand the positive impact humans **can** have on the environment when they are growing and maintaining fruiting trees and bushes on their land. By demonstrating the ecological benefits of these fruiting trees, our volunteer team could eventually help to inform policies that support local communities and stress the importance of private land conservation, much like what we do here in our area to inform private landowners on best management practices and habitat restoration.

Our task was to count the number of birds and other wildlife eating the fruit we could see around us over a 10 minute period. We collected data on 16 different private farm parcels, or "fincas." Led by trained field ecologists, we traversed the amazing mountainous landscape, spent time in mysterious cloud and rain forest habitats, and shared farm fields with cows, horses, and chickens.

In between observations, our project leaders would take time to show us other wonders of the tropical forest, such as vampire bats roosting in the hollow of a tree and the amazing siting of a common potoo chick sitting



perfectly still at the top of a dead tree, waiting for its parents to return. As a birder, I was thrilled to add another 39 bird species to my life list!

I came back from Costa Rica encouraged on the positive results being observed so far, and that private land conservation will continue to play a significant role in counteracting the inevitable changes happening to our climate and our planet's health. Together, we can make a difference right here in our region.

Land, Partnership, and Vision

It began with a phone call between OLT and The Nature Conservancy (TNC), and ended a year later in five new properties and 187 acres under our belt.

How? We were in the midst of brainstorming how to fundraise for protecting a riverfront parcel spanning the Towns of Milford and Middlefield, an awesome one at that. TNC also realized the untapped potential of this parcel and hopped on the bandwagon. Yes, this property's conservation values are *that* inspiring.

TNC helped us purchase the parcel from Ed and Mary Greenaker, providing 97% of the purchase costs. A full project suite blossomed out of the two organizations' partnership and coordination to conserve new lands and transfer some already protected lands within the Upper Susquehanna Watershed Region to OLT from TNC. The partnership was critical in tying everything together. TNC contributed \$185,000 in total towards acquisition costs and our future management of these lands.

They're in our hands now, so what's next for these parcels?

The Blueway Spreads its Wings

We're adding two new places for you and your families to explore! That's right, The Blueway is branching out to provide more public access opportunities across the region.





Lordsland Preserve

With ownership now transferred from TNC to OLT, Lordsland Preserve is now part of our Blueway public access properties. Located in the Town of Roseboom, you can visit and walk along 1.4 miles of walking trails through forests, wetlands, meadows, and steep slopes.

While you're out, keep your eyes peeled for Jacob's Ladder, a flowering plant that blooms in early spring to early summer with a ladder-like arrangement of leaves and numerous nodding flowers on top.

According to the New York Natural Heritage Program, Lordsland is one the best locations for finding this beauty, but please be considerate and practice the "take only pictures, leave only footprints" mantra that allows our Blueway properties to remain healthy and beautiful for all visitors.



CONSERVATION EASEMENT Buying Land to Protect Land: Success in Oneonta

ast December, Linda Wilcox, encouraged by her husband Jim Johnson, donated a conservation easement on 133 acres of beautiful forests, hills, farmland, and wetlands, a piece of land they've fondly named Hilltop Woods, located in the Town of Oneonta.

Protection of this property will help reduce land fragmentation in this rural area near the City of Oneonta.

Seeing that there was a very clear present development threat in the area, the landowners chose to purchase and protect the property in order to conserve its farmland, forests, diverse wildlife habitats, stream and wetland buffers, and natural area corridors.

Future generations will benefit from the protection of land that impacts drinking water for both the Town and City of Oneonta.

The conservation easement also protects important soils suitable for future agricultural endeavors and nearly 60 acres of forest land, which may help reduce erosion, improve water quality, and mitigate the effects of climate change through carbon sequestration and sound management of working lands.

"We are encouraged by Linda's commitment to conservation and congratulate her for permanently protecting land to limit sprawl. There is slow but continuing development in this area, as the property is in close proximity to the City of Oneonta. Increased development could threaten the quality of the drinking water supply of the City and other municipalities."
